DESCRIPTION OF DUTIES:

UNDER THE GENERAL SUPERVISION OF THE SHIFT LIEUTENANT, IS
RESPONSIBLE FOR THE OVERALL SUPERVISION OF SUBORDINATE SECURITY
ASSIGNED TO THE HOUSING UNITS, AND FOR THE SUPERVISION, CUSTODY AND
CONTROL OF ALL INMATES ASSIGNED TO THE HOUSING UNITS. MAKE ROUTINE
INSPECTION OF THE LIVING AREAS FOR COMPLIANCE WITH SECURITY, SAFETY
AND SANITATION STANDARDS. CONDUCT INVESTIGATIONS OF ALLEGED
MISCONDUCT ON THE PART OF INMATES AND SECURITY PERSONNEL ASSIGNED TO
THE AREA OF RESPONSIBILITY. ASSIST IN CONDUCTING FORMAL AND INFORMAL
COUNTS. SUPERVISES THE JOB PERFORMANCE, CONDUCT AND APPEARANCE OF
ASSIGNED SECURITY PERSONNEL. PREPARE EMPLOYEE'S EVALUATIONS.
COUNSEL/RECOMMEND DISCIPLINARY ACTION AND TRAIN SUBORDINATE STAFF
TO REQUIRED STANDARDS OF PERFORMANCE. PREPARE REPORTS AS NEEDED.
