PERFORMANCE; PROVIDES DIRECT SUPERVISION TO SUBORDINATE OFFICERS.  
REVIEWS INCIDENT REPORTS WRITTEN BY OFFICERS. INSTRUCTS AND COUNSELS  
OFFICERS CONCERNING DUTY REQUIREMENTS. INVESTIGATES INMATE COMPLAINTS  
AND TAKES APPROPRIATE ACTION; INSTRUCTS AND COUNSELS INMATES AS  
REQUIRED. MONITORS INMATE MOVEMENT WITHIN THE INSTITUTION. PERFORMS  
ESSENTIAL AND MARGINAL DUTIES OF AN OFFICER II; PERFORMS ALL OTHER
